PRELIMINARY & FINAL REGISTRATION

Preliminary Entries

Each national federation entering the 12th European & Mediterranean Junior Outdoor Target Archery Championships must submit a preliminary entry by using the Preliminary Entry Form not later than April 13, 2010.

A maximum number of 3 athletes per national federation are allowed to be registered into each category of this event.

Entry Fee

- Entry fee per athlete € 150,00
- Entry fee per team € 150,00

There is no entry fee for officials.

The entry fee includes daily local transport to and from the competition field/training field to the official hotels as well as the costs of doping control.

Final Entries

Each national federation must submit a final entry by using the Final Entry Forms not later than June 13, 2010.

Please pay attention to the stated deadlines. The Organizing Committee reserves the right to refuse any entry after the deadline for the final entries has passed if such entry would cause a change in the program or cause other organizational problems.

GENERAL INFORMATION

Location

The 12th European & Mediterranean Junior Outdoor Target Archery Championships will take place in Winnenden. The city is located in the Southwest of Germany at an altitude of 278 m. The nearest airport is Stuttgart (35 km).

Competition Field

The competition will be held in the Herbert-Winter-Stadium, Albertviller Strasse 46, 71364 Winnenden, Germany about 2 km away from the city center.

Training

There will be a training field available beginning on Sunday July 11, 2010 and is located right next to the competition field.

Team Captains Meeting

The Team Captains Meeting will be held on Tuesday July 13, 2010 at 13:00 in the Stadium near the competition range.

European Junior Cup

The 12th European & Mediterranean Junior Outdoor Target Archery Championships is also valid as final leg of European Junior Cup and the winners of the European Junior Cup Circuit will receive EMAU medals.

Award Ceremonies

The ceremonies will take place for teams (also mixed teams) directly after the team finals and for individuals directly after individual finals in the Stadium. Please bring along your national anthem (CD or USB) and 2 national flags (90 cm x 120 cm appr.)

Doping Control

On behalf of EMAU the Organizing Committee will conduct doping control tests (finishing placement tests, random tests and target tests) according to the FITA Anti-Doping Rules.

ADDITIONAL INFORMATION

Transportation

The registration fee includes shuttle transportation between official hotels and the competition/practice field. Transportation from the hotels will start on the official practice day and will end the day of the finals. The delegations will find the schedules for shuttle transportation in their pigeonhole in the organizing office.

Your registration fee does not include your airport transportation from Stuttgart Airport. If you need transportation from/to Stuttgart Airport please let the Organizing Committee know on the Transportation Form. Transportation from Stuttgart Airport to the official hotels will start 3 days before the official practice day and will end the day after the finals. It can only be provided if the organizing committee receives the arrival and departure details not later than **June 13, 2010**.

Transportation to/from Stuttgart Airport will cost EUR 40,00 per person (round trip).

VISA

Application for and obtaining travel visas are completely and solely the responsibility of the participating teams. The process for obtaining a visa requires each individual to submit an application through a German Embassy or German Consulate. This is a process that **MUST** be done by the applicant – the organizing committee cannot do it for you! It cannot be emphasized enough to start the application process early. Please note that the application and interview process in your country may very well be in advance of the team selection date, so in many cases, you will need to start the application process prior to confirming your final team.

Letter of Invitation – All countries that will need Letter of Invitation by the German Shooting Sports & Archery Federation to use in their application process are requested to order these in time. Please fill out the Visa Support / Official Invitation Form as soon as possible and send it in.

As long as the Organizing Committee gets no different information, the Letter of Invitation will be sent by fax and/or email. If an express service should be desired, this service will be charged to the federation and must be paid to the Organizing Committee upon arrival.

Weather Information

In July the average maximum air temperature is 23°C and the average minimum air temperature is 12°C. As July is considered to be the hottest month the temperature may reach more than 30°C at daytime. You can expect 73 l/m² of rain in July.

Catering / Meals at the Competition Field

The local organizers will offer lunch near the competition field at the price of EUR 10,00 per person/day. There will be three different lunches inclusive one vegetarian meal. To order lunches please fill in the Lunch Order Form and return it to the Local Organizers no later than **June 13, 2010**.

I for myself and on behalf of my heirs, assigns and next of kin, hereby release, hold harmless and promise not to sue EMAU, their Officers, Officials, Organisers, Agents, Sponsors and/or Employees and/or other representatives ("The EMAU Agents"), with respect to any and all such injury, paralysis, dismemberment, death and/or loss or damage arising from my participation in the except that which is resultant of gross negligence and/or willful or wanton misconduct by EMAU and/or EMAU agents.
4. I promise to abide by all EMAU rules, regulations, decisions and rulings, including without limitation all those relating to doping or use of drugs. I agree to submit all disputes or claims of any nature relating to the Event (including without limitation its conduct, sponsorship and my participation therein), EMAU rules, regulations, rulings and decisions on all subjects to binding arbitration before the Court of Arbitration for Sport under its statutes and regulations.

I consent and agree to the creation of my profile in WADA Doping Control Clearing House (ADAMS) and/or any other authorized National Anti-doping Organisations (NADOs) similar system under FITA's agreement for the sharing of information, and to the entry on my doping control and Therapeutic Use Exemptions related data in such systems.
4. I acknowledge and agree that FITA and its Member Associations have jurisdiction to impose sanctions as provided in the FITA Anti-Doping Rules (*).
5. I also acknowledge and agree that any dispute arising out of a decision made pursuant to the FITA Anti-Doping Rules (*), after exhaustion of the process expressly provided for in the FITA Anti-Doping Rules (*), may be appealed exclusively as provided in Article 13 of the FITA Anti-Doping Rules (*) to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport.
6. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
