Motion submitted by EMAU Council C&R, article n. 1.5.2, 1.5.7

Increase the Council Members by 2 Members.

The Congress elects 6 Council Members.

The President, one Vice-President and three Council Members shall be elected at the Congress held at the European Outdoor Championships, held in the year of the Summer Olympics.

One Vice President and three Council Members shall be elected at the Congress held at the European Outdoor Championships two years after the Summer Olympic Games.

Reason

Enlarge the Council adding 2 members in order to involve increasingly our Member Associations in EMAU.

If the Congress approves this motion, the election of 4 Members will take place in the Congress 2008 under the respective Agenda-point for elections. 3 members will be elected for a period of 4 years, one will be elected for a period of 2 years.

Add a new Committee

3D/Field Committee

3 Members are elected by the Congress. The Chairman will be appointed by EMAU Council. The Committee will work with the FITA Field Committee and the 3D ad hoc Committee.

Reason

As this discipline is growing its importance and as FITA already organized a World Championships and EMAU is organizing an European Championships, it is important that the 3D activity is guarded by a proper EMAU Committee

If the Congress approves this motion, the election of the Members of the 3D Committee will also take place in the 2008 Congress under the respective Agenda-point for elections.

Reason

As in 2010 the IOC will organize the 1st Youth Olympic Games, FITA has to change the rotation of the Youth World Championships from even to odd years. As a result, EMAU will change the European Indoor Championships from the even to odd years and the European Outdoor Junior Championships from odd to even years. (There will be however two consecutive European Indoor Championships in 2010 and 2011)

To be added 3.3.4.1: When the new European Record is shot on the tournament controlled by the appointed EMAU Technical Delegate, this Record will be confirmed automatically by the Secretary General upon receiving the EMAU Records Claim Form without sending the scoresheet and the results list.

Not recommended by EMAU Council.

EMAU should have the same procedure with the scoresheets as in FITA. It is the responsibility of the Member Associations or the archer himself to claim a record.
