Qualification Round

- Recurve Bow: Fita Round (all distances with 6x6 arrows, at 50m for juniors and at 40m for cadets 10-5 scoring rings target face, at 30m 10-6 scoring rings target face)
- Compound bow: Compound 50m Round (72 arrows in ends of 6 arrows on 10-5 scoring rings target face.)

Individual Elimination Rounds & Finals:

- Recurve: set system – up to 5 sets of 3 arrows (Cadets on 60m, Juniors on 70m)
The archers obtaining 6 set points will win the match.

- Compound: matches – 5 ends of 3 arrows and cumulative scores on a 10-5 scoring rings target face (Cadets and Juniors on 50m)

The archer having obtained the highest total score will win the match.

Team Elimination Round & Finals: 4x6 arrows and cumulative score (no changes).

3. I consent and agree to the creation of my profile in WADA Doping Control Clearing House (ADAMS) and/or any other authorized National Anti-doping Organisations (NADOs) similar system under FITA's agreement for the sharing of information, and to the entry on my doping control and Therapeutic Use Exemptions related data in such systems.
4. I acknowledge and agree that FITA and its Member Associations have jurisdiction to impose sanctions as provided in the FITA Anti-Doping Rules (*).
