PRELIMINARY & FINAL REGISTRATION

No entry forms will be available for registering in this event.

The registration process has to be done using the FITA Online Registration System (FORS, V.2) www.archery.org/admin

A maximum number of 6 athletes per country are allowed to be registered into each category of the event (the host country is allowed to register 8 archers).

Preliminary entries have to be done using the FORS, V.2:

In order to be able to use FORS, please enter this address in your web browser (www.archery.org/admin) and use the Username and Password that FITA has assigned to each Member Association. After entering the FORS, please go to "Online Registration" and register your archers for this event.

Please pay attention to the stated deadlines. After passing the deadlines, MAs would not be able to enter or update their data in FORS anymore, as the system will be blocked. In this case, if any MA would like to change or proceed with the Final Registrations process or change their Final entry, it is required to contact Mr. Matteo Pisani at email: <u>pisani@net-tech.it</u> with a copy to Organizing Committee email <u>cafkotox@cytanet.com.cy</u>

Final registration that will differ for more than **2** archers according to preliminary registration will have a penalty fee of **€100** to be paid to the OC at the moment of arriving at the event.

Teams that enter after **15th May 2012** will pay a penalty of €100 per athlete to be paid to the OC on arrival for the tournament (article 3.3 EMAU agreement).

A Member Association that has made final entries in FORS and does not participate will be invoiced for the number of entries entered in the system, unless the MA informs the OC by email <u>cafkotox@cytanet.com.cy</u> at latest one week prior to the event that they are not be able to attend.









Since entries are through the FORS only, Member Associations declare that their athletes and officials are aware of the participation waiver and anti doping agreement. We recommend Member Associations to advise their athletes on this matter. However, accepting the conditions of the athlete participation waiver and the anti doping are eligible to participate in the event.

Only Member Associations in good standing will be eligible to compete. This also means that any penalty fee for 2011 and/or 2012 FITA fee will have to be paid prior to this Grand Prix.

ADDITIONAL INFORMATION

Entry fees:

Individuals:	€120 per Archer.
<u>Teams</u> :	free of charge.
Officials:	free of charge.

Participation in the Mixed Teams event is **free of charge**.

The entry fee includes daily transport to and from fields/hotel. Transport timetable will be available.

Participants who decide to book their accommodation in other hotels (nonofficial) will have to pay a **double entry fee**, and the OC will not be responsible for providing transportation from those hotels to the venue. Furthermore they have to register at accreditation at the latest the day before the official practice; if they do not register the day before, no changes will be made to the entry list. It is likely that they will not be allowed to compete if registration was not completed on time.

Transportation:

Larnaca Airport and Nicosia – Larnaca airpot: € 30 per Person Larnaca airport is approximately 55 km, 45 minutes drive from Nicosia.

Awards Ceremony:

You are requested to bring your National anthem (on a CD) and your Country's Flag (90cm x 120cm approx).

Club Archers Participation

Not only National Team archers can participate in a Grand Prix, but also Club archers. National teams will have priority during the preliminary entry phase. After the preliminary entry deadline all Club members could register. The Club archers can participate only in the individual competition, not in team competition and in mixed team. Registrations must be done through their National Federations and

the entries can be accepted by the Organizing Committee until the total capacity of the field has been reached.

Field, hotel and buses will be available for disable persons.

Prepayment:

Booking will be considered valid as soon as a minimum 50% payment has been received by the Organising Committee. You will be asked to present the prepayment receipts at the check-in. Full payments have to be made at the registration of the Tournament.

VISA

Application for obtaining entry visas (for the countries that need such a visa) is the responsibility of the participating teams. The process for obtaining a visa requires each individual to submit an application through a Cyprus Embassy or Cyprus Consulate. This is a process that MUST be done by the applicant – the organizing committee cannot do it for you! It cannot be emphasized enough to start the application process early.

LETTER OF INVITATION

All countries that need Letter of Invitation by the Cyprus Archery Federation for use in their application process are requested to ask this in time. Please fill out the Visa Support / Official Invitation Form as soon as possible and send it in. As long as the Organizing Committee gets no different information, the Letter of Invitation will be send by fax and/or email.

OPENING CEREMONY

Opening ceremony will be held on Monday, 4th June 2012. FITA dress code will be required.

PARTY

There will be a party held at Saturday evening, 9th June 2012. The participation fee is €15 per person and has to be paid to the Organizers in advance.


