3.3 Official Practice, Practice & Training

• General regulation for all practice fields

Only the archers taking part of the European Championships can shoot on the practice fields.

Nobody else will be allowed to shoot on it during all the duration of the championships.

• Official Practice - Official FOP

Cf. Official Schedule

• Free practice

The time of opening of the practice field will be written on the official schedule.























During the elimination rounds stages, priority will be given to archers or teams involved in the matches.

During the days of finals, another practice field will be at disposal for archers involved in the medal matches only. Presentation of the accreditation card is mandatory in order to have access to the practice field.

Warm-up is at the assigned targets per session.

The time of warm-up will be indicated on the official schedule for each round

Team Elimination Round Practice: 20 min before the competition.

3.4. Equipment Inspection

Teams must be registered before Official Practice and Equipment Inspection. No one will be allowed to get to the competition and practice venues without accreditations cards. Equipment inspection will run on the field of play, at the same time as the Official practice. Each team will be called (following alphabetical order) and invited to come to the designated place for this inspection. All team members should wear their team uniform. Archers have to come with their classification card. We are kindly asking to all the archers and coaches to follow the OC volunteers and Judges Instructions to proceed with no delays and as organized as possible.

3.5. Qualification Round and information on scoring

During the qualification round and elimination rounds, the scorecard has to be signed by the archer himself/herself.

During the finals (Bronze medal and Gold medal matches) the agent signs the scorecard on behalf of the archer or team.

Please double check between electronic device and scorecards, and please make sure that each archer of your team is aware that all the data requested in the scorecards must be filled in and scorecards signed.

3.6. Shoot-off new rule

The new rule to apply is this one:























14.5.2.2. Individuals:

A single arrow shoot-off for score;

- If both archer score a 10 (recurve) or X (compound) on their first shoot-off arrow, then the match would be considered a tie and a second shoot-off arrow will be needed to resolve the match;
- If the score is the same the arrow closest to the centre of the target face shall resolve the tie and if the distance is the same, successive single arrow shoot-offs, until the tie is resolved.
- If both athletes miss the scoring area of the target, both athletes will shoot an additional arrow.

Case of W1 is missing in the writing of the rule. For this event the "10" will be considered for the first point for the W1 categories.

3.7. Appeal Procedure (Form attached)

In case of an Appeal, the Appeal Form should be given to the Chairman of Judges or to his deputy. In order to proceed with an appeal, a deposit 40 Euros should be given to the WAE TD (Or Chairman of Judges) for the appeal to be valid.

3.8. The medal matches as spectator

The archers or teams who want to watch the medal matches as spectator are kindly invited to encourage the other participants.

Places are reserved for them in some tribunes. The accreditation card is a mandatory to have free access to these tribunes

4) Technical Matters (WAE TD + chairman of Judges)

4.1. Timing Control system

For the competition, two different systems of timing system will be used on the both fields to avoid mistakes of hearing the signals.

4.2. Rules that apply in this event (WA rules)

Rules for Indoor and WA official interpretations.

For Recurve division, we will use Recurve target faces and for Compound division, the Compound target faces will be used.























5) Logistical Aspects (OC)

5.1 Transportation

The shuttle schedule will be published in the official hotels and at the venue and updated if needed during the championships.

All teams are requested to check and confirm their departure details (return flight confirmation, number of person, etc..) which will be posted on the boards in the hotels.

Public transport can be used for transportation between hotels and venues. Pilsen City Transport Company ensures the majority of public transport in the Pilsen area. We advise to use tram no. 2 to get to the Qualification and Training venue (Malesická stop).

Few tips for easy travel by Public Transport of Pilsen

- It is advisable to purchase a ticket before entering the carriage. A ticket sold by a driver is more expensive and its purchase prolongs the time spent at the stop.
- Online ticket: SMS to 90206 text "pmdp35m"
- Inside the carriage is the contactless card pay machine which is usually in the middle of the tram/bus.



- When entering the carriage with a wheelchair, a pram or a dog, use the doors that are designated for this only - they are marked by a symbol of wheelchair, pram or dog.
- It is necessary to inform the driver by a hand wave before entering the carriage with a pram, a wheelchair, a bicycle, a large piece of luggage or dog and wait for his/her consent or























refusal.

- Transporting bicycles is permitted during weekends and on public holidays only.
- Front doors in buses and trolleybuses are designated for physically disabled passengers only
 or can be used in case the passenger wants to purchase a ticket from the driver.
- To get off, it is necessary to press a self-service button to open the door (it is green in most carriages)
- For boarding at a request stop, it is necessary to visibly signal with your arm to the driver in advance. Press the "STOP" button when getting off.

5.2 Meals

Breakfast and Dinners are arranged in the hotels.

Breakfast from 12th to 19th of August 06:00 - 10:00

Dinners from 11th to 17th of August 18:00 - 21:00

Dinner on 18th will be served at Closing Party at 19:00.

Lunch

From 12th to 16th, lunch is arranged at the venue.

For the finals days 17th and 18th, teams will receive lunch vouchers which can be used at food stands next to the final venue on the square.

Lunch from 12th to 16th of August 11:30 to 14:30

Lunch from 17th to 18th of August 11:00 to 15:00

5.3 VI Classification

Departure from Hotel to go to the clinic will be at 08:45 on Sunday 12th August.

As for other classification, the medical examination and discussion will be in English. Please ensure that someone who can translate will be with your archer if he doesn't speak English himself.

6) Protocol and ceremonies (OC)

6.1. Opening Ceremony

Teams are requested to provide one member of the team as the flag-bearer 15min before the start of Ceremony.

6.2. Medal Ceremonies

Award ceremonies will take place each half-day, just after the last medal match (cf. official schedule) Archers who are involved are kindly invited to stay at the final venue, to be immediately available after the last match of the half-day.

The podium will be installed on the final venue.

Protocol is part of the competition. Teams, athletes and/or official are asked to respect it as well, mostly during the national anthems of the winning countries, WAE fanfare, and Local National anthem.

6.3. Closing Banquet & Party

The dinner will be served at the Closing Party (no dinner in hotels)

7) Medical Related issues (Medical representative)

First Aid Services will be available in the Archery Venue.

8) Doping Test

8.1. Doping control

Doping control will be done following WAE rules.

9) Dress Regulation (WAE TD)

Athletes, officials and staff should have a proper appearance when are present on the field. Athletes and Technicians should wear no other kind of footwear than sport-shoes. This is a WAE European





















Championships so WAE dress regulations do apply. Please refer to WA rules: 3.22.1.1 to 3.22.1.5 included

10) Other matters of importance (WAE TD & EM)

10.1. Environment

Team Managers, please instruct your team members to use the litter bins provided which are located on the competition, practice ranges and common areas.

10.2. Water

During the event, every accredited person has the right to get free water.

In effort to protect the environment, each accredited participant will receive own bottle with logos of the championships. Water tank and nutrition drink tank will be placed at the venue and each participant will be able to refill his bottle anytime.

10.3. Communication

All results and updated documents for TM will be on http://ianseo.net/Details.php?toId=3149 All important changes in schedule etc. will be placed at the information boards in the hotels and at the venue and published on lanseo competition page.

10.4. Non Smoking

This is a non-smoking event. Smoking is forbidden inside public buildings and all competition and training areas. There are designated smoking areas outside the FOP.

10.5. Mixed Zone and Press Conferences

Interviews will take place at the Mixed Zone at the exit of final venue. Athletes will be requested to pass through the mixed zone to speak with the media.

10.6. Internet access

A local network is usable at the venue.

To ensure that Team Managers will have efficient access to online updated information and























documents, there will be network allowing access to lanseo web page.

10.7. Hotels internal rules

Each one must respect rules on the field AND out of the field during all the Championships.

We remind that in all hotels it is strictly forbidden to cook or to smoke in rooms. If you don't respect it, you'll have to pay fine issued by the hotel.

11) Open meeting about Visually Impaired categories

Since few years WA and WAE support the development of archery for Visually Impaired archers which is a big challenge.

We are happy to have them in this Championship. This is a good opportunity to highlight these categories and to discuss about options to increase the participation of VI archers in the future.

Pippa BRITTON, World Archery Para-Archery Liaison will be present. VI archers, their coaches and every people of the team's staff who want to attend this meeting will be welcome.







































4 reasons why it is worth visiting Pilsen:
